## **PRINCIPLE TERMS OF MEMBERSHIP AGREEMENT**

Seven day members may play golf at anytime subject to availability.  
Midweek members may play golf at all permitted times Monday - Friday, excl bank holidays.  
Corporate members may play golf at anytime from Monday - Friday. And can play on Saturday, Sunday and bank holidays after 11am.

Membership is an initial commitment from the date of joining until the following rate review date each year.

Membership joining fees and subscription fees, inclusive of current VAT charges, fixed by Blakes, are reviewed annually and may be altered at any time, with immediate effect. Members are notified in writing of any changes with a minimum of two weeks notice.

### **BLAKES MEMBERSHIP RULES**

In addition to these Membership Rules concerning the administration of Membership, Members attention is drawn to the Club Rules, which include local rules, golf etiquette, opening times, dress code, smoking policy, car parking and mobile phone usage, etc. Members who use the Club with children should also refer to the 'Supervision of Juniors'.

Identification, which includes the new Members signature, will be required at the time of joining. For new Members wishing to pay by Standing Order, we will also require confirmation of your bank account details (i.e. bank card).

The Club reserves the right to reject an application for membership, or refuse admission, without ascribing any reason for doing so.

Signing the application form attached to these Blakes Membership Rules will form a legally binding contract between the Membership and the Club. Members are also signing their agreement to abide by these and any other Club Rules, Regulations and guidelines that may be posted on the Club's notice board.

At enrolment, Members will be asked to pay their full subscription plus Green union fee or three months subscription plus green union fee. If paying by monthly instalment, we will issue you with a standing order form. You will be responsible for setting payment to commence one month after joining date.

Standing orders must be paid on the same day of every month. In the event of subscriptions not being paid on the due date, access to Blakes may be refused.

The Club will charge an administration fee of £10 if a Member's commitment to pay any monthly subscription instalment is not honoured.

Should you fail to meet your ongoing commitment to pay subscriptions, access to Blakes premises will be refused.

All members intending to resign their membership shall do so in writing with two months notice. No refund will be granted and your membership will be terminated with immediate affect.

### **TERMINATION OF MEMBERSHIP**

Blakes reserves the right to refuse admission and/or expel any Member forthwith if any Member shall, in the opinion of the Club, cause nuisance, annoyance, breach any Rules, or



for any other reason which the Club may deem appropriate. In the event of any dispute the General Manager's decision shall be final.

### **MEMBERSHIP CARDS**

All Members will be issued with Membership cards, which they must carry when visiting Blakes. They must be shown to Reception on arrival and Members of the Club Management Team when asked to do so. The loss of a card should be reported immediately to Blakes staff. Any misuse of Membership cards will result in an immediate cancellation of Membership. New or replacement membership cards will be charged at £10 a card.

### **SUPERVISION OF JUNIORS**

For safety and security reasons, all children under the age of 14 must be supervised by an adult at all times whilst on the Club premises. Parents are reminded that they are responsible for their child's behavior when visiting the Club.

### **LIABILITY**

All Members, and their Guests, use Club facilities at their own risk, and Blakes will accept no responsibility for any illness or injury however caused, other than liability that may arise from negligence of Blakes or its Staff.

Blakes liability for damage or loss to Member's property is strictly limited to any damage or loss suffered as a result of negligence of Blakes staff. With this exception Blakes will not accept liability for money, valuables or other personal property of Members and Guests. Property stored in lockers provided by Blakes is stored at the owner's risk and the Club therefore will accept no liability for loss or damage.

Vehicles, motorcycles and bicycles, parked or left at Blakes car parks or elsewhere on the premises and all contents in them or on them, are left at the owner's risk. The Club will accept no liability for loss or damage in respect thereof.

Any Member or Guest who suffers an accident on the Club premises, or in its grounds, must report the accident and the circumstances under which it occurred, to the General Manager or Duty Manager at the Club immediately following the accident.

By signing for this Membership you are agreeing to be bound by these Rules and it is your responsibility to be aware of them.

All Members are entitled to use the social facilities of Blakes with certain restrictions according to licensing laws.
